## **TERMS & CONDITIONS OF ENROLMENT:**

## **DUTY OF CARE, SAFETY & CONDUCT**

- 1) I understand that the physical activity in dance class involves a certain amount of risk. I give consent for the above-named student to participate in dance classes at their own risk. I understand that all students are responsible for their own conduct, behaviours and safety whilst on the premises. I release Dance Generation Performing Arts School from any claims, actions, costs, liabilities, or expenses arising from the above-named student's and/or signatory's participation in any Dance Generation Performing Art School activities.
- 2) I understand the above-named student's and/or signatory will be held financially responsible for any damages sustained to Dance Generation Performing Arts School's property, and will be charge for any repairs, labour or replacement of property.
- 3) I understand that Dance Generation Performing Arts School does not accept responsibility for any damage or loss of goods on the premises prior to, during or after dance classes. I understand that the above-named student's and/or signatory are solely responsible for their personal belongings whilst on the premises. Please ensure all dance wear/shoes are labelled with student's name.

### **CONSENT**

#### **CLASS PAYMENTS**

- 5) I understand payment for full term fees must be paid in full by the second week of term or by the second week of enrolment. I understand that the late payment of fees will incur a late fee charge of \$10.00 per week that the fees remain outstanding. I am aware that if there is a shared custody arrangement for the above-named student, arrangements must be made by the parents to ensure pay fees are paid on time. Students who are eighteen years or over may pay weekly. However, these weekly payments must be received prior to the commencement of the dance class. I understand all variations of term payments are non-refundable under any circumstance.
- 6) I understand that in the event that Dance Generation Performing Arts School does not receive the above-named students full term or weekly payments, the above-named student will not be permitted to participate in any dance classes. Additionally, students who fees are outstanding will not be permitted to purchase any tickets or costumes for any Dance Generation Performing Art School performances.
- 7) I understand that any outstanding payments for term fees will be referred to a debt collector. I understand that the above-named student's and/or signatory is responsible for all charges associated with their dance classes and debt recovery.

### **CLASS DISCOUNTS**

8)	Students participating in FIVE hours of dance per week are entitled to participate in additional
	classes, excluding private lessons, free of term fees. Term fees which are not paid in full are not
	entitled to this discount

9) A family discount of 10% applies to families with THREE or more children enrolled. Term fees which are not paid in full are not entitled to this discount.

### **CLASS ATTENDANCE**

- **10)** Term dates coincide with Victorian School term dates. No classes will be held on public holidays. Class times and days are subject to change at the discretion of teachers.
- 11) I understand that students who are unable to attend their dance class must advise their teacher prior to the class or contact Penny Higgs on 0417 020 783. I understand the the above-named student will be charged the full amount for the class in the event they arrive late to a dance class. If absent from class for any reason fees will not be refundable, however a child has permission to attend an equivalent class in order to make up the hours that were lost.
- **12)** I understand that it is the student's responsibility to notify teachers prior to the dance class of any injury or medical condition that is being treated or that may be of concern during class.
